2. Discuss what is included in the Team Folders:

- a. Membership Cards are included this season. Captains were asked to double check that names are spelled correctly. If not get with Kelly to get a corrected card made out. This is how they are spelled in the LRDA records and how they will appear on any trophies or awards.

- b. Score sheets will still be mailed in this season. If a captain wants to know if a phone photo is readable they can send them to [littlerockdarts@gmail.com](mailto:littlerockdarts@gmail.com) for verification but they will still have to mail in the originals this season. Not all phones take quality photos.
  - c. Go over the Team Captains/Bar Location list to verify phone numbers are correct. If there is an incorrect phone number or if there is a change to the Captain/Co-Captain please be sure to let Kelly know so the list can be updated. It is posted on the LRDA.org website and needs to be kept accurate.
3. Go over updated By-Laws They are being placed on file with the state in order for LRDA to maintain its non-profit status. A question was raised on how a league member could facilitate a change to the by-laws. By-laws (or governing rules) for non-profits are, according to the state of Arkansas, set by the board of directors of that non-profit. If a league member believes a change needs to be made to those by-laws they can present a written proposal to the Board of Directors showing what they think needs to change and how. The board will then review the request and vote on it. The results of that vote should appear in the minutes to that board meeting.
4. Discuss the playoff criteria and vote on # of Matches vs # of Games as the primary qualifier. A question of which to chose as the primary qualifier for playoffs was brought forth. Should it be overall matches win/loss record or the total number of games won/loss. The Majority of the captains present who voiced a preference stated that the overall matches should be the first qualifier.
5. Open floor for any other issues or questions.  
This season the stats will reflect the actual number of games played for each match (singles and doubles). There will no longer be half games recorded for double matches when calculating QPA's for a league member.
