3. Seed teams by Division for Spring Season

It will also include a canned food drive for the food bank as an additional charity event.

8. In other issues: Due to personal issues Mark Brown is unable to perform his duties as Rules Chairman. The board has asked Brian Mebert to stand in until the August elections and he agreed to the temporary position.

Criteria for Lifetime Membership in the league were touched on. An agreement could not be reached at this meeting as to what exactly that would entail so it was tabled until next month.
