4. Discuss upcoming events

- a. Playoffs: Playoffs begin with round 1 on Wednesday November 18th. Round 2 will be held on Thursday November 19th There should be a board member present at each location each night to verify the winning teams and report them to the League Secretary. - b. Top 40/16 Tournament

If they cannot perform their duties they are responsible for finding someone to do so for them.

 Awards: Chris will be responsible for ordering/picking up the awards from Discount Trophy, Kelly will provide him with a list of 1st/2nd place teams Trifecta recipients, Hi QPA's and League Champions.
 LOD: The league will pitch in an additional \$100 to the LOD.

a. Next Season

Rosters- Rosters will need to be turned in by December 7th. Captains may either Mail in the roster, e-mail the roster or text a legible photo of the roster to Kelly. She will send out an email in the next week to this effect.

Membership fees/dues – Next season a reduced seasonal fee of \$10 will be charged to play. For those who have not already paid their membership dues they will need to pay an additional \$10 for the season.

Sponsorship (BAR) fees – Bar fees for bar's just now opening due to Covid will be given a 1 season pass on sponsorship fees. A reduced sponsorship fee of \$25 per team is being asked of the bars that sponsored teams last season.

Next Fall (2021) the intention is to go back to standard fees for Membership dues (\$10 annually), seasonal fees (\$20 per season) Bar Sponsorship fees (\$35 per team per season)
